Unscientific and Manipulative

Thomas Mayer and a group of over 50 anonymous people in Switzerland and Germany report in the book *Corona Vaccinations from a Spiritual Perspective* on their 'supernatural observations' on the Covid 19 disease and the corona vaccinations.

The various working groups, which appear to be loosely linked, assume that each vaccine is a living being. The vaccines were "examined" by e.g. B. who held vaccine ampoules in his hand. Perceptions of "extremely evil" beings with a "will to destroy" (p. 84) against everything human and the correspondingly destructive effects of the vaccines are described.

In a shorter section, therapists report on their experiences with vaccinated people, in whom they felt densification and less ability to vibrate in the tissue and hardening in the soul and describe damage to the aura of the vaccinated people. The authors describe in detail the corona vaccination damage that they observed in the deceased. Their life after death would be massively affected by the vaccines, with corresponding consequences for future incarnations. But the Covid disease itself is "as massive as five (which five?) diseases together" (p. 136).

Conspiratorial attitude of the book

The book consists of four parts: perception reports, contributions by other authors, discussion and summary. In the subchapter Sense Perceptible, the authors claim that there are effective drugs that are deliberately concealed in order to build up vaccination pressure. Lockdowns and the restriction of fundamental rights are also a means of extortion. The PCR test plays a key role in identifying those who test positive as infected, although it is "at best a 'contamination" (p. 23). The vaccinations are ineffective, but very harmful to health and associated with high death rates. Mayer goes even further in the discussion section. Sars-CoV-2 was created in the laboratory with "black magic" (p. 305) intention. The release of the virus was not an accident, but by an international "vaccination and virus mafia" (p. 308) deliberately brought about.

Minimal criteria of spiritual science are not met

The systematic, self-critical exercise and development of extrasensory perception is a declared goal of the anthroposophical schooling path. If people want to be active on this path, this requires a corresponding transparency and methodical cleanliness to a much greater extent than in conventional scientific research. The usual basic requirements of scientific work include conscientiousness, self-critical questioning of one's own approach, transparency with regard to the conditionality of the research method and object, restraint in judgements, disclosure of motivational and conflicting interests, etc. This book does not meet these requirements in any way:

• With allegedly more than 50 anonymous authors, a minimum of transparency is missing.

• From the outset, the book is so extremely positioned in the corona and vaccine sceptical narrative and thus negative expectations that there was no objective observation situation. The sensational style also indicates that there was a lack of the necessary sobriety and impartiality. At no point in the book does a self-critical questioning of one's own approach become apparent.

• There are no indications of any other scientific activities of the secret groups. As far as we know, there are no discursive working relationships between these groups and anthroposophic medicine.

• The book tries massively to incite fear and is not freeing, as one would expect from serious spiritual science. Statements that cannot be verified warn against vaccination, as in the past in church threats against agony. The authors use the same fear reflex with which they accuse politics.

• In scientific research, one often arrives at deviating results, depending on the observation context. Even when reading Rudolf Steiner's texts one encounters at least apparent contradictions when spiritual facts are looked at from different perspectives. With Mayer and his employees, there is only one thing: all 50 people always come to the same, irrevocable result. This lacks any credibility.

• Among the anthroposophic physicians, to which the authors of this review belong, many are involved in the care of Covid patients as well as vaccinated and unvaccinated people and have a wealth of experience from trained observation. Our own observations contradict the presentation in the book submitted by Mayer.

Damage to anthroposophy

Methodologically, this work is not serious in all recognizable areas, it is unscientific, manipulative and has nothing to do with anthroposophic spiritual science and anthroposophic medicine. When it comes to gaining a deeper understanding of the signatures of the current situation, a solid scientific methodology is needed, to which Anthroposophy and the medicine inspired by it feel committed.

The damage to anthroposophy that will result from this well-selling book cannot yet be foreseen. The co-authors remain anonymous because they "do not want to become the target of a defamation campaign" (p. 17), but do not shy away from claiming Rudolf Steiner and his anthroposophy for their dubious work, because exactly what Rudolf Steiner would have predicted is what is described in the book. This claim must be clearly rejected. In the work published by Rudolf Steiner himself there is no support for such a statement, neither in the content nor much less in the methodical manner of presentation.
